b) Purpose of the photographs is:

- Non-Commercial own use by Model, Visagist and Photographer
- Website and/or Portfolio Model, Visagist & Photographer

The model may use and publish the photographs for promotion of his/her work as a model, only with reference to the name of the photographer as maker of the photographs. Said publication can be on Social media websites such as Google+ or Facebook, and modeling websites such as ModelMayhem or Modelzone and in print on portfolio pages. Any other publication of the photographs by the model without prior written consent of the photographer is not allowed. The model is not allowed to post photographs on a for-pay website or otherwise sell photographs. The model is not allowed to provide usage rights to any third party. The model holds full portrait rights to his/her image.

(If Applicable) Visagist has the same usage and publication rights as the model, with the same limitations. Visagist does not have portrait rights to any depicted image.

The photographer has undivided copyrights of the photographs, including the right to publication. The photographer may use and publish the photographs for promotional purposes of his work as a photographer, but with reference to the name of model and visagist. Photographs can be published on his portfolio or website, Social media such as Facebook or Google+, Photo Websites such as Instagram or Flickr, Photofora such as www.zoom.nl, Photo Exhibitions and professional Photographer Contests.

All other publication will be discussed and approved in writing among photographer and model.

c) Model and Visagist will not receive any financial compensation for the TFP photoshoot. Model and Visagist will receive digital access to a selection of the photos (unprocessed). Out of this selection Model and Visagist can each choose 7 to 10 photographs for post-processing. Model and Visagist receive the end-result in digital form in 72ppi web resolution .JPG. All photographs can exclusively be used in unaltered format and the photographers name shall not be removed or changed.

d) If any of the involved parties wants to publish photographs in another form than mentioned under d0, this is only allowed after

1. the other have given written permission for said publication, and
2. parties have made a written agreement on the applicable financial compensation.

In any case will the photographer request the model to provide explicit and written permission to use any work for publication other than mentioned under b). In case the photographer will use one or more photographs for financial-commercial purposes, photographer and model will agree in writing to the compensation which will be due to the model. This similarly applies to the compensation for the visagist, if any.
